Traditional Project management is a methodology put-forth by the Project Management Institute, USA. This methodology has been widely accepted and implemented by scores of industries worldwide. On the other hand, Projects in Controlled Environments, version2 (PRINCE2), the British Project Management methodology is also well-known and widely implemented. Both of these methodologies have their own advantages and pitfalls. Their suitability to projects varies and in some cases depends on the nature of the project.
