This thesis presents a comprehensive analysis of the liability of Internet Service Providers (ISPs) in cases of third-party copyright infringement, examining regulatory frameworks across several jurisdictions: the USA, EU, Australia, Singapore, India, and Pakistan, with a particular focus on Section 35 of the Prevention of Electronic Crimes Act (PECA) in Pakistan. Through a comparative lens, the study evaluates the legal provisions, judicial interpretations, and practical implications concerning ISP liability. The research delves into the divergent approaches adopted by each jurisdiction, exploring the extent of ISP responsibility, the criteria for safe harbor protections, and the mechanisms for addressing copyright infringement online.
