ABSTRACT

This study, "Analysis of the investment in the textile sector over the past three years - in the WTO perspective" has been carried out by Zara Basharat under the supervision of Sir Aurengzeb in order to fulfill the requirement BBA (hons) degree, the report compromises a total of 55 pages. And is being submitted on September 15, 2004.

The study is descriptive in nature and has used secondary data for analysis. It analyzes the present state of affairs prevailing in he textile and clothing sector of Pakistan. The study examines the challenges faced and the opportunities available, especially under the WTO regime. The role of competitors has also been analyzed. The cost of doing business in Pakistan is too high; it has been recommended that this cost should be significantly reduced, so that young entrepreneurs are attracted to the sector
